This edition of the European Heritage Policy Agora will focus on drawing links between flagship EU policies, such as the Green Deal and the <u>New European Bauhaus</u>, and key heritage conservation documents, such as the <u>European Quality Principles</u>, developed by ICOMOS on European Commission's request, and the <u>Davos Baukultur Quality System</u>, emanating from the <u>2018 Davos Declaration</u>.

The dialogue will emphasise the importance of quality in cultural heritage restoration and preservation, explore ways to make policy and practice more interconnected, and identify gaps for action. The event will provide an opportunity to discuss priorities in cultural heritage management ahead of the formation of the new European Commission.

The Policy Agora will benefit from the contributions of a wide variety of public and private heritage stakeholders, including policy-makers at all levels, civil society representatives, young heritage professionals and cultural actors.





SNEŠKA QUAEDVLIEG-MIHAILOVIĆ Secretary General Europa Nostra


Sneška Quaedvlieg-Mihailović has dedicated her life to championing Europe's shared values and shared cultural heritage, working for Europa Nostra for over three decades and assuming the role of Secretary General in 2000.

In 2022, Sneška was elevated to the rank of Knight of the national order of the Legion of Honour for her "unreserved commitment to the preservation of heritage in Serbia and more widely in Europe" and "dedication and commitment to the cultural dimension of the European project".

A prominent figure in cultural heritage discourse, Sneška serves as a spokesperson for the European Heritage Alliance and currently serves on the EC Expert Group on Cultural Heritage. Her influence extends to climate action as regional co-Chair of the Climate Heritage Network. She is a member of the Europeana Foundation Advisory Board, the EUYO Advisory Council and the Steering Committee of the European Music Centre in Bougival.

Before joining Europa Nostra, Sneška worked for the EU Institutions in Brussels and Belgrade. She was one of the founders and first Secretary-General of the European Movement in Yugoslavia. Sneška holds a graduate degree in International Law (Belgrade, former Yugoslavia) and a postgraduate degree in European Law and Politics (Nancy, France).

HERMANN PARZINGER Executive President Europa Nostra


Prof. Dr. Hermann Parzinger has been Executive President of Europa Nostra since 2018. He has also held the office of President of the Stiftung Preussischer Kulturbesitz (SPK) (Prussian Cultural Heritage Foundation) since 2008. Consisting of 27 museums, libraries, archives, and research institutions, the SPK is the second-largest cultural institution in the world. Its collections include all areas of cultural tradition: from archaeological and ethnological objects, to the visual arts, literature and music.

As President of the SPK, Hermann Parzinger is in charge of two major cultural projects: The renovation of the world-famous Museum Island and the realisation of the Humboldt Forum in the reconstructed Berlin Palace; he was one of the founding directors of the Humboldt Forum.

Prof. Parzinger has conducted 30 years of field research in many European countries as well as in the Near East and in Central Asia. Before joining SPK he was an Assistant Professor at Munich University (1986-90), Director (1990-2003) and President (2003-2008) of the German Archaeological Institute. In 1996 he was appointed Honorary Professor at Free University in Berlin.

Hermann Parzinger has received many awards, among them the Leibniz Prize, the highest scientific award in Germany. He holds several international Honorary Doctoral degrees, he is member of Academies of Sciences in Germany, Spain, Great Britain, Rumania, Russia, China and the USA and has received decorations from Germany, Russia and Italy.


STEFAN BÂLICI President of the Romanian Order of Architects

Ștefan Bâlici is President of OAR – The Romanian Order of Architects since July 2022. Since 2000, he is also an Associate Professor at the Chair for Architecture History and Conservation of Cultural Heritage of the "Ion Mincu" University of Architecture and Urbanism, Bucharest, teaching architecture conservation, with a focus on archaeological heritage.

He has been active in several professional and civil society organisations, among which Europa Nostra and ICOMOS, he is a founding member of the Association ARA (Architecture. Restoration. Archaeology), for which he had been project coordinator from 2006 to 2016. He was also a managing partner and conservation planner with OPUS Architecture Studio, Bucharest, from 2001 to 2016. From 2016 to 2022, he headed the National Institute of Heritage, where he was responsible for the implementation of public policies and programmes for the conservation of cultural heritage in Romania.

As a conservation architect, he has overseen conservation projects for important historic monuments and sites in Romania, such as the Archaeological heritage of Ancient Callatis, The Roman Fortress at Sarmizegetusa Regia, Bran Castle, and Alma Vii Fortified Church.

#### RIIN ALATALU Vice-President of ICOMOS


Riin Alatalu, Vice-President of ICOMOS; Associate Professor of cultural heritage and conservation in Estonian Academy of Arts; Coordinator of UNESCO Chair in Heritage Studies in Estonian Academy of Arts; Vice-Chair of Estonian Heritage Conservation Council; Member of ICOMOS Rights-Based Approaches working group, CIVVIH, ICLAFI and ISC20C, Member of European Heritage Label Panel.

Alatalu has worked in the National Heritage Board, Tallinn Culture and Heritage Department and Estonian Ministry of Culture in leading positions.

PhD: Heritage in Transitional Society from Nation's Conscience in the Estonian SSR into the Harasser of the private Owner in the Republic of Estonia, 2012. Alatalu has actively participated in Urban Agenda Dissonant heritage working group, advocated for the preservation and contextualisation of dissonant heritage in Estonia and organised several related courses and lectures.

Alatalu has run several campaigns including Estonian National Cultural Heritage year in 2013, European Cultural Heritage Days, Visit Baltic Manors and other awareness raising activities. She has initiated cooperation with decision makers and a wider audience.

Since January 2024, Normunds Popens is the Deputy Director General in the Directorate General for Education, Youth, Sport and Culture.




OANA ZAHARIA Director General of National Institute of Heritage






#### OLIVER MARTIN Chair of the Davos Baukultur Alliance

Oliver Martin holds a Master's degree and PhD in Architecture from the Swiss Federal Institute of Technology Zurich. Oliver Martin held various positions at the Swiss Federal Office of Culture until he joined its executive board in 2012 as Head of the Baukultur section. In parallel, he was a member of the Swiss delegation to the UNESCO World Heritage Committee from 2010 to 2013 and was a member of ICCROM Council from 2013 to 2021, serving as president from 2017 to 2021. He is one of the main authors and promoters of the concept of Baukultur and the related Davos Declaration, adopted by the European Ministers of Culture in 2018, which became a reference text for building and planning policies in Europe and beyond. Oliver Martin is the Chair of the Davos Baukultur Alliance, launched in 2023 in cooperation with the World Economic Forum.


### JACEK PURCHLA Vice-President of Europa Nostra, Chair of the European Heritage Awards Jury

Jacek Purchla is a Full Professor of Humanities and a member of the Polish Academy of Arts and Sciences. He holds the title of Doctor honoris causa from the National University of Lviv Polytechnic.

At Jagiellonian University, he serves as President of the Board, while also leading as Head of the Department of Economic and Social History at Cracow University of Economics. He was the founder of the International Cultural Centre in Krakow and was its Director from its inception in 1991 until 2018. He is a member of numerous international organisations and associations, including the Comité International d'Histoire de l'Art (CIHA). He advised the European Commission in the European Heritage Label project. Since 2015, he has been President of the Polish National Commission for UNESCO. 




JERMINA STANOJEV EU Research and Policy Expert, KU Leuven

THEMIS CHRISTOPHIDOU Director General, DG Regional and Urban Policy, European Commission






### ANDREW POTTS Heritage & Climate Action Advisor, Europa Nostra/European Heritage Hub






#### FRANZISKA HAAS President of ICOMOS ISCES






IHOR POSHYVAILO Director of the Museum of the Revolution

Dr. Ihor Poshyvailo (Kyiv, Ukraine) is a general director of the National Museum of Revolution of Dignity (Maidan Museum). He is a cultural activist, ethnologist, museologist, and art curator. Ihor is an ex-chairman of the Museum Council at the Ukrainian Ministry of Culture, and a vice-chair of the ICOM-DRMC. He holds a Ph.D. in History and is a corresponding Member of the Archaeological Institute of America (USA). He was a Fulbright Scholar at the Smithsonian Institution. When the large-scale Russian-Ukrainian war started in 2022 Ihor became the initiator and coordinator of the Heritage Emergency Response Initiative (HERI) and a member of the National Council for Reconstruction of Ukraine from the War. In 2023 Ihor received the Cultural Protection Award (CPAs) of the International Arts & amp; Antiquities Security Forum (IAASF), UK, and the Archaeological Institute of America Award for Outstanding Public Service (USA). In 2024, he won the Kenneth Hudson Award for Institutional Courage and Professional Integrity from the European Museum Forum.




LORENZO VENEZIA Young Heritage Professional trained in cultural property protection, ESACH
